WATER COMMISSIONERS' REPORT

To the Citizens of the West and South Water Supply District of Acton:

We present the annual report for the year ending March 10, 1930.

Our power plant is in very good condition, the general repairs having been looked after and kept up at a time when

We think the standpipe may need painting this year and this we have in mind as it should not be neglected.

We have moved the hydrant at the foot of Standpipe hill on Main Street back from the road to a safe position.

We have also put in one new hydrant on Main Street which will take care of the new houses that have been built on this street in the last year. Also we might say here that in working on new hydrants or replacing old hydrants we are placing new six inch controlling valves at the hydrant which will be of great advantage, as when any work has to be done at the hydrant it can be shut off without shutting water off in the main pipe line and leaving a part of the water district without water while the work is being done.

We have added twelve new services this year and one service has been discontinued.

In making up our estimate for last year we did not make any allowance for the bad break on Main Street in our ten inch main pipe line, which added much to our expense for the past year, thus cutting down our small margin of gains income that we are obliged to work on for a few years at least. We are not looking for any trouble with our main pipe lines this year.
