You are directed to notify and warn the inhabitants of the Town of Acton residing in the Water Supply District, as bounded and defined by Chapter 326 of the Acts of 1912, Sections 1 and 13 of said Act, qualified to vote in elections and town affairs, to assemble in FIREMAN'S HALL, WEST ACTON.

TUESDAY, APRIL 7, 1931, at Eight O'Clock P. M.

then and there to act on the following articles, to wit:

ARTICLE 1. To choose a Moderator to preside at said meeting.
ART. 2. To elect by ballot one Member of the Board of Water
Commissioners, to serve for the term of three years.

ART. 3. To choose all necessary District Officers and fix

Salaries.

ART. 4. To hear and act on the reports of the Water Commissioners, Treasurer, and other officers of the District or any Committee appointed at any previous meeting.

ART. 5. To see if the District will authorize the Treasurer to borrow money, with the approval of the Water Commissioners if

necessary, in anticipation of revenue the current year.

ART. 6. To see if the District will instruct the Water Commissioners to petition the Legislature to extend the bounds of the District commencing at the District bound on Main Street to a town bound Acton, Maynard and Concord; thence by the Concord line to a bound on Massachusetts Ave.; thence to the Stone District bound in Main Street near the John McCarthy house or act anything thereon.

And you are directed to serve this warrant by posting copies, attested by you, in the several post offices, railroad stations and stores in the District seven days at least before the time of holding said meeting.

of holding said meeting.

WATER COMMISSIONERS' REPORT

To the Citizens of the West and South Water Supply District of Acton:

We present the annual report for the year ending March 15, 1931.

This year we have added five new services, and at the West School House, the one inch pipe was replaced, with two inch pipe, as it was found after installing flush toilets, at the School, the one inch pipe was not large enough to give the quick flow of water when flushing. On Main Street, near the Grain Mill, South Acton, we have moved the hydrant back of the sidewalk, and put in a six inch valve. As this hydrant has been hit by automobiles, and four times put out of commission, it was thought best to move the hydrant to a place of safety.

Owing to the very dry season this last year, we did not think it best to paint the standpipe as the water would have to be drawn from it for about two weeks. The Commissioners hope to do it this year. However, it has been surprising, and also pleasing, with such a dry season as we had last summer and fall, that the water in our wells did not lower but a very little, this showing that we must have an abundant supply of water to draw from.

This year, in addition to painting the Standpipe, we must raise the hydrant on Main Street near the house of Mrs. Hatch, as the road has been widened and filled at this point, making the hydrant too near the traveled road. Some work will also have to be done at the Pumping Station this year, on the pumps and a little work on the engines, in the way of overhauling, but this will not involve any very large expense.

We are pleased to note that the financial condition of the Water District is improving each year, and last year made the best showing since we have been without a District Tax.
