You are directed to notify and warn the inhabitants of the Town of Acton residing in the Water Supply District, as bounded and defined by Chapter 326 of the Acts of 1912, Sections 1 and 13 of said Act, qualified to vote in elections and town affairs, to assemble in FIREMAN'S HALL, WEST ACTON

TUESDAY, APRIL 4, 1933, at Eight O'Clock P. M. then and there to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

WATER COMMISSIONERS' REPORT

To the Citizens of the West and South Water Supply District of Acton:

We present herewith our annual report for the year ending March 15, 1933.

Very little work has been carried on outside of the general repairs and upkeep of our plant, necessary repairs are being kept up at all times.

Near the Fire House at South Acton one hydrant was taken out and replaced with a new one. On Main Street, two hydrants were raised to the new street level. With each of these hydrants a new six-inch main hydrant valve was installed.

All hydrants have been checked up and given a coat of rust killer paint. All woodwork on the Pumping Station and Tool House have had two coats of paint.

Two new services have been installed this year, making a total at the present time, six hundred and three.

We are now having a chart made of all the house services in the Water District which will be a help in locating house service shut off boxes which means a great deal in time of a leak or break in a service pipe.

AUDITOR'S REPORT

West Acton, Mass. March 25, 1933

To the Honorable Board of Water Commissioners: Gentlemen:

The accounts of the Collector and Acting Treasurer have been examined by me and found correct to the best of my knowledge.

An examination of the accounts of the former Treasurer revealed many irregularities over a period of several months.

Upon reconciling the bank balance for the year, I find a discrepancy between the actual cash and the book figures totaling \$1,558.71.

This condition has been brought to the attention of the company covering the surety bonds for the district.

Unusual circumstances presented an opportunity for such manipulation. The fiscal year for the Water District ends on March 31 annually and for the Town of Acton, December 31. The Treasurer, elected by the district in the past, has likewise served the town in a similar capacity.

With the closing dates so far removed from each other, the practice of "juggling" funds from one account to another might have continued without detection indefinitely.

As a precautionary measure against collusion with outside funds, I recommend:

That officers of the district receive and disburse district funds exclusively.

I further advise:

That the Collector remit by check twice monthly whenever the accumulation exceeds \$100.00.

That the Treasurer shall be required to immediately deposit all such sums in the bank.

That the Treasurer be permitted to retain a petty cash fund not exceeding \$50.00.
